
# **GUADALUPE REGIONAL FLOOD PLANNING**

### STATE AND REGIONAL FLOOD PLANNING


In 2019, the Texas Legislature created a state and regional flood planning process for Texas in the wake of historic flooding. Through this process administered by the Texas Water Development Board (TWDB) the state designated 15 planning area regions, including the Region 11 Guadalupe Regional Flood Planning Region. The 15 planning regions are tasked with developing regional flood plans to identify flood prone areas and assess ways to address flooding through the first-ever statewide flood plan. The Region 11 Guadalupe Flood Planning Region is administered by the Guadalupe-Blanco River Authority. The actual planning for the region is led by a committee of volunteer members, called the Guadalupe Regional Flood Planning Group.



## **GUADALUPE REGIONAL FLOOD PLANNING GROUP**

The purpose of the Guadalupe Regional Flood Planning Group (RFPG) is to provide comprehensive regional flood planning and develop a regional flood plan. The plan identifies both short and long-term flood risks and recommends Flood Management Strategies (FMS) and Flood Management Projects (FMP) and estimates the funding required to implement these solutions in order to protect against the loss of life and property.

The planning group is comprised of 15 volunteer members representing 12 interest categories throughout the Guadalupe River basin. Planning group meetings are generally held monthly.




#### **PLANNING TIMELINE**
